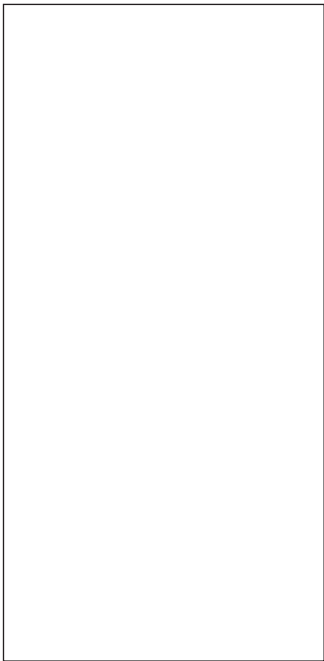
Sixty years ago independent garage owners were on their own when it came to navigating the industry. Then in 1955, Ralph James of Oklahoma, along with other independent garage owners, formed Independent Garage Owners of America (IGOA). The early goals included training programs; bonding of shops; registering of mechanics; safety inspection laws; group benefits; and liaisons with the government. Later in 1955, a group of garage owners in Lancaster County affiliated with IGOA by forming the Independent Garage Owners of Pennsylvania, Inc. (IGOP). During the early 1960s, IGOP grew when 15 units (chapters) in the state joined the ranks.

In 1972 IGOP's name changed to Automotive Service Councils of Pennsylvania (ASCP) after merging with the Pennsylvania Auto Body Association (PABA). The merger established a division for auto body and included more members and eight more chapters to our growing association.

In 1986, a consolidation of the industry's two U.S. leading associations at the time Automotive Service Council, Inc. (ASC) and Independent Automotive Service Association (IASA)) led to another name change for our state association; we would now be known as the Automotive Service Association of Pennsylvania (ASAP). We again changed our name, and this time our affiliation too, on January 1, 1999, by using the name Automotive Service Professionals (ASP) of Pennsylvania. The name was later modified to our current name of the Alliance of Automotive Service Providers (AASP).

Presently, our Association has 29 chapters, representing Pennsylvania's independent automotive service providers. We offer a variety of benefits to our members, included training opportunities, a lobbyist to help us fight what's important to the automotive industry in Pennsylvania, and up-to-date industry information.

The one constant through our history: our commitment to our members and their concerns. AASP-PA will continue to be proactive on behalf of our members—now and in the future.
